NOTICE TO BIDDERS

Sealed bids will be received by the LAMBERTVILLE MUNICIPAL UTILITIES AUTHORITY, Lambertville, New Jersey for the supplying of Replacement Media for the Authority's Biofilter.

Proposals will be received up until 10:00 A. M. on May 6, 2021 at which time they will be opened using the Zoom Meeting Platform in the Authority office located in the Office Education Building at the site of the Wastewater Treatment Plant, 3 Bridge Street, Lambertville, New Jersey. Details on the Zoom Meeting Platform for the Bid Opening will be available on the Authority's website, lambertvillemua.com. Proposals must be sent by either U.S. Postal Service, overnight delivery, or hand delivery. As the Authority Office is closed to visitors, the Bidder must contact the Authority by telephone at 609-397-1496 to arrange acceptance of hand delivered bids.

Full sets of Bidding Documents will be available from the Lambertville Municipal Utilities Authority beginning on April 15, 2021 at 8:00 a.m. Bidding Documents can be sent via email upon request or can be shipped **only** if the requesting party includes their overnight shipping service number.

Proposals must be made on standard proposal forms in the manner designated and required by the specifications.

No bidder may withdraw their Bid for a period of sixty calendar days after the actual date of the opening of the Bids except in accordance with the provisions of N.J.S.A. 40A:11-50.3.

The successful bidder must furnish a 100-percent Performance Bond with a surety company licensed in the State of New Jersey, listed in U.S. Treasury Circular 570.

Complete instructions for filing Bids are included in the Instructions to Bidders.

Bidders are required to comply with the requirements of Public Law 1975, c. 127 (N.J.A.C. 17:27 Affirmative Action). This Bid and Contract are subject to New Jersey Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.). Each Bidder must submit with the bid a Non-Collusion Affidavit in accordance with the Contract Documents. Bidders and their subcontractors are required to comply with P.L. 2004, c.57 (N.J.S.A. 52:32-44 et seq.). Failure to submit the New Jersey Business Registration Certificate with the bid in accordance with N.J.S.A. 52:32-44 et seq. will be cause for mandatory rejection of the bid as being non-responsive.

If the bidder is a corporation or a partnership, the bidder, in conformance with Chapter 33, P.L. 1977, shall submit with its Bid, a statement setting forth the names and addresses of all stockholders who own a ten percent (10%) or greater interest in the corporation or partnership.

Prospective bidders are cautioned not to rely solely on this Notice to Bidders in preparing their bids, but to read the Contract Documents in their entirety and comply with all bidding requirements set forth therein.

The Lambertville Municipal Utilities Authority reserves the right to reject any or all bids, should the owner deem it to be in the public interest to do so.
